GENERAL INSTRUCTIONS:

- ❖ Candidates who had registered for Round-1 or Round-2 and did not get any seat allotted are not required to register again. Also, candidates who have been allotted but not joined in Round-1 or Round-2 need not register again.
- ❖ Candidates who have joined the seats in Round-1 or Round -2 and wish to opt for upgradation need not pay Registration fee again but they have to login during the Registration Window to confirm their participation in Round 3 so as to include their seats as Virtual Vacancies.
- ❖ Fresh registration is permitted in Round -3 for those candidates who have not registered in Round-1 or Round-2 (with full payment of fees). But, candidates should have already applied to Tamil Nadu Medical Selection Committee and their names should be in the Merit List already published.
- ❖ Candidates who wish to retain their seats (who don't want a change in college) need not participate in this Round.
- ❖ Candidates whose names are in the allotted list provided by MCC at the end of Round 3 will not be eligible for State Quota Round 3 counselling.
- ❖ If opted for and upgraded in Round 3, the candidate **has to relinquish** the seat from Round 1 or Round 2 and join the Round 3 allotted seat. He/She will not have any rights over the Round-1 or Round- 2 seats.
- ❖ Round- 3 choice filling will follow the registration and candidates who wish for upgradation, un-allotted candidates and not joined candidates have to fill their choices.
- ❖ Candidates should be careful while choice filling and it is advisable to choose preferred colleges only.

- ❖ Candidate could edit their Choice(s) but once the candidate locks their choice(s) during the online counselling, it cannot be changed later.
- ❖ If the candidate is re-allotted in Round 3, then the MBBS/BDS seat allotted to candidate during Round 1 or Round 2 of Counselling will be allotted to other candidates **IN DESCENDING ORDER, NOT IN ASCENDING ORDER.**
- ❖ Once the candidate has joined the seat in Round- 3, candidate cannot upgrade or Resign from this seat.
- ❖ If any candidate downloads the allotment order and does not join the Round- 3 allotted seat is considered as joined and they will have to forfeit the Registration fee, Security Deposit & Tuition fee paid by him/her and they will also be **not eligible to participate** in the subsequent Rounds of Counselling.
- ❖ If any candidate is allotted in Round-3 but has not downloaded the allotment Order, they will have to forfeit the Registration fee and Security Deposit and they will also be **not eligible to participate** in the subsequent Rounds of Counselling.
- ❖ Candidates who participated in Round-3 but were allotted the same seats will be considered as Retained. And all the rules of Round 3 will apply to them (forfeiture of Security Deposit and Tuition fee, Discontinuation fee and Elimination from further rounds of Counselling)
- ❖ Vacancies for the Course will be available on the official website.
- ❖ As per the prospectus, any remaining unfilled seats for want of adequate number of eligible candidates belonging to SCA community shall be filled by candidates belonging to SC community as per merit and vice versa (G.O. (Ms) No. 55, P & A R Dept. Dated 08.04.2010). Hence the candidates belonging to SC Community can register and Choice lock for remaining unfilled SCA Seats also.
- ❖ As per the prospectus, any remaining reserved seats in ST quota for want of adequate number of eligible candidates belonging to ST community shall be filled by candidates belonging to SC community as per merit (G.O.(Ms)

No.77, H & FW Department, dated 24.02.2011). Hence the candidates belonging to SC Community can register and Choice lock for remaining unfilled ST Seats also.

- ❖ As per the prospectus, any remaining unfilled seats in BCM community for want of adequate number of eligible candidates after exhausting the merit list shall be filled up on merit basis by candidates belonging to BC community without exceeding the quota for BC community as a whole (G.O. (Ms) No.30, H & FW Dept. dated 18.01.2012). Hence the candidates belonging to BC Community can register and Choice lock for remaining unfilled BCM Seats also.
- ❖ As per the prospectus, even after filling up of the required seats reserved for Arunthathiyars on preferential basis, if more number of qualified Arunthathiyars are available, such excess number of candidates of Arunthathiyars shall be entitled to compete with the scheduled castes other than Arunthathiyars in the inter-se Merit among them (As per the G.O. (Ms) No.65, P& AR(K) Dept, dated 27-07-2009). Hence the candidates belonging to SCA Community can register and Choice lock for remaining unfilled SC Seats also.
- ❖ Candidates can edit their choices any number of times before locking, but once locked they will not be allowed to edit.
- ❖ Selection committee does not take responsibility for Connectivity error and Procedural error.
- ❖ Admission to MBBS/BDS Degrees courses shall be made by the ONLINE COUNSELLING on the basis of rank by applying the rule of reservation.
- ❖ **Virtual vacancies:** Any candidate who has been allotted a seat in Round 1 or Round 2 and has opted for upgradation by registering in the website in Round 3, that allotted seat of Round 1 or Round 2 will be shown as virtual vacancy in Round 3 and all candidates can fill their choice for the said seat during the choice filling in Round 3. However, such seats will be allotted in Round 3, only if the allotted candidate of Round 1 or Round 2 vacates/upgrades in Round 3 then that virtual vacancy becomes a real vacancy.
- ❖ All candidates should read the Prospectus thoroughly before starting choice filling.

- ❖ Candidates should be careful while choice filling.
- ❖ If the candidate does not lock his/her choices till the last date (14.10.2025 AT 05.00 PM) their choices will be automatically locked.

INSTRUCTIONS FOR ALLOTTED CANDIDATES:

- ❖ If a candidate is allotted in Round 3, he/she will have to join the allotted college. Allotted candidates during Round 3 ***will not be eligible for Subsequent Stray Vacancy round*** (and additional rounds if any)
- ❖ The allotted candidate for MBBS seats in all colleges under all categories and BDS seats in Government Dental Colleges has to pay the Tuition Fee for downloading the Provisional allotment order through online via Debit Card / Credit Card/Net Banking.
- ❖ The Selected candidates belonging to SC/SCA/ST/ SCC who have been allotted seat in Govt. Quota and Management Quota in self-financing Medical colleges are exempted from paying tuition fee for downloading the allotment order if annual income of Parents/ Guardian is less than 2.5 Lakhs.
- ❖ The Selected candidate (BDS seats in Self Financing Dental Colleges) has to pay the Tuition Fee at the time of admission to the colleges directly as per G.O(D) No.868 Health and Family Welfare (MCA-1) Department dated.18.07.2023 as detailed in the Notification No.010/SCS1(1)/2023 dated 19.07.2023.
- ❖ Fee structure is available in the official website www.tnmedicalselection.net
- ❖ All candidates should make sure, sufficient fund is available at their bank account with expanded credit/Transaction limit while remitting their Tuition Fee.
- ❖ The allotted candidates should download their provisional allotment order and join the course in the concerned Medical College/Institution on or before the stipulated date and time as mentioned in the Provisional Allotment Order.

REPORTING TO ALLOTTED COLLEGE:

- ❖ The Certificate Verification will be done in the selected colleges itself.

- ❖ The candidates should produce their ORIGINAL CERTIFICATES in person at the time of joining in their selected Colleges along with the scanned copy of original certificates for verification.
- ❖ If you do not report to the Head of the Institution to which you are allotted on or before the time and date specified, your selection and / or admission will be cancelled without any further notice.
- ❖ The Candidate selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he/she is liable for forfeiture of selection / admission if suppression of facts, mis-interpretation is found at any time during or after the admission to the course.
- ❖ Candidates are advised to be in touch with our official website (www.tnmedicalselection.net) for Schedule / latest updates / Results / Notices / News & Events pertaining to counselling as Selection Committee will not be individually contacting the candidates for the same.
