- i. This Fee is all inclusive of Annual Tuition Fee excluding Books and required Equipment, Hostel fees, Transport fees and Food expenses, etc.
- ii. The Institutions shall not be entitled to collect any kind of Fees under any guise except fees as fixed by the Fee Committee. Any deviation will amount of violation of the Orders of the Hon'ble Supreme Court of India and stringent action will have to be taken against the Management of such Institution by the appropriate Authorities like Government of Puducherry, National Medical Council (NMC) and the Pondicherry University. The penal action for violation shall also include withdrawal of approval by the NMC and disaffiliation by the University concerned along with hefty fine as penalty.
- iii. The appropriate Fee structure fixed as above for the respective Institutions, shall be the maximum fee for the respective course and the Institutions shall be at liberty to fix a fee structure lower than the fee fixed by the Fee Committee, if it so desires.
