### **UGNEET-2025 – Stray Vacancy Round seat allotment to AYUSH Courses**

Stray Vacancy round seat allotment will be conducted for admission to AYUSH courses as per the schedule given below. The AYUSH seats which remained unfilled / cancelled / newly added if any after third round seat allotment will be considered for the seat allotment in Stray Vacancy round.

### **Eligibility:**

Candidates who have joined Dental Colleges and candidates who have joined Medical Colleges allotted in the previous rounds and have provisionally allotted seats in the 3rd round of Medical or Dental seat allotments are not eligible to participate.

Candidates who have reported to the College after the allotment of seats in the first, second or mop-up round of All India Counselling/Deemed University/Central University etc. are also not eligible to participate in the AYUSH Stage Vacancy round of UGINEET 2025.

Candidates are advised to check the availability of seats and check the fee details of various colleges before participating in the Stage Vacancy round.

Candidates are advised to check the fee details, confirm and discuss with their parents before participating in this round.

Other candidates interested in AYUSH seats can participate in this round after confirming receipt of original documents from the present college within the stipulated time. Once a seat is allotted in the Stray Vacancy round, the seat previously allotted will be cancelled and they will not be able to get back the old seat for any reason. It is mandatory to take admission in the college for the allotted seat.

It is the responsibility of the candidates to obtain original documents from the current college to get admission in the newly allotted college within the stipulated date and time.

As per Government Order No. AKUKA 345 PIM 2025 Bangalore dated 02-08-2025, the remaining NRI seats will be allotted under the Others quota at the same NRI fee, hence all the candidates interested in NRI seats can register their options for NRI seats.

# Fees paid for other courses have already been transferred to colleges and will not be adjusted for AYUSH courses.

Candidates must report to the allotted college on or before the stipulated last date. If a candidate fails to report to the allotted college, he will not have any seat. Such candidates will also lose both the seats and the fee will not be refunded. It is mandatory to report to the allotted college.

### Entry of Fresh Options: 06-11-2025 from 6.00 PM to 09-11-2025 at 6.00 PM

- 1. Eligible candidates interested in participating in this round should enter their options fresh. The options entered earlier will not be considered.
- 2. The period for entry of options will not be extended for any reason.
- 3. Candidates whose seats are allotted on the basis of merit and the options entered by the candidate must compulsorily take admission in the allotted seat.

#### Note:

Since such seats are also allotted in case of cancellation or new addition of seats, candidates are advised to enter their options even if the availability of seats is not shown in the seat matrix.
