AYURVEDA/HOMOEOPATHIC/SIDDHA/UNANI/MEDICAL ALLIED
COURSES-2025 FACILITY MADE AVAILABLE

The activities related to the first phase allotment to Medical & Medical Allied Courses (BAMS, BSMS, BHMS, BUMS, BSc.(Hons.) Agri., BSc. (Hons.) Forestry, BSc.(Hons.) Co-Operation & Banking, BSc.(Hons.) Climate Change & Environmental Science, B.Tech. Biotechnology, BVSc. & AH, BFSc) for the State Quota Seats for the academic year 2025-26 have commenced. Those candidates who are included in the Ayurveda and Medical rank lists published by the Commissioner for Entrance Examinations and who are eligible for such courses as per NEET UG 2025 Information Bulletin can register options to Ayurveda, Medical/Medical Allied courses respectively through the website **www.cee.kerala.gov.in** till **10.09.2025, 4.00 PM**. Based on the options received up to **10.09.2025, 4.00PM**, the provisional allotment list will be published on **11.09.2025**. In this phase of allotment, candidates can register options to the following courses:

1. Bachelor of Ayurvedic Medicine and Surgery (BAMS)
2. Bachelor of Siddha Medicine and Surgery (BSMS)
3. Bachelor of Homoeopathic Medicine and Surgery (BHMS)
4. Bachelor of Unani Medicine and Surgery (BUMS)
5. Bachelor of Science-Agriculture [BSc.(Hons.) Agri.]
6. Bachelor of Science-Forestry [BSc.(Hons.) Forestry]
7. Bachelor of Science-[BSc.(Hons.)] Co-Operation & Banking/[BSc.(Hons.)] Agri. Business Management
8. Bachelor of Science -[BSc.(Hons.)] Climate Change & Environmental Science
9. Bachelor of Technology - B.Tech. Biotechnology.
10. Bachelor of Veterinary Science & Animal Husbandry (BVSc. & AH).
11. Bachelor of Fisheries Science (BFSc.)

Candidates shall give options afresh to consider in the allotment to

Ayurveda/Homoeopathy/Siddha/Unani/Agriculture/Co-Operation & Banking/ Veterinary/ Forestry/ Fisheries/Climate change & Environmental Science/B.Tech Biotechnology through the website **www.cee.kerala.gov.in**.

Allotment to 15% All India Quota Seats in Self Financing Ayurveda/Siddha/Unani colleges will be conducted by the Commissioner for Entrance Examinations. The allotment to such seats will be conducted on the basis of the options registered in this phase as per the State Rank list for respective courses without considering domicile.

Mandatory Reservation

Leaving the seats set apart for All India Quota, Government of India Nominees, Special Reservations, Persons with Disabilities, Minority /NRI Quota seats, the remaining seats for each course will be distributed as per the mandatory reservation principle as contemplated in G.O. (P) No.208/66/Edn.Dtd.2/5/1966, G.O. (Ms)No.95/08/SCSTDD, Dtd. 6/10/2008, G.O.(Ms)No. 10/2014/BCDD Dtd.23.05.2014 and as modified from time to time.

OPTION REGISTRATION FEE:

Those candidates who wish to register options will have to remit option registration fee of Rs.5,000/- (Rupees Five Thousand Only) to the Commissioner for Entrance Examinations . The registration fee will be adjusted in the tuition fee of those candidates who take admission consequent to allotments. Candidates belonging to SC/ST/OEC category and those having benefits as per G.O.(Ms) No.25/2005/SCSTDD Dated 20.06.2005 and G.O.(Ms)No.10/2014/BCDD Dated 23.05.2014 and those candidates from Juvenile Home, Nirbhaya Home, Sree Chitra Home will have to remit Rs.500 /- (Rupees Five Hundred only) as Registration Fee.

The Registration Fee of such candidates who take admission in the allotted college/course will be adjusted in the caution deposit. Those candidates who have already paid option registration fee for MBBS/BDS courses need NOT pay again. The registration fee of those candidates who do not get allotment will be refunded. (Bank account details shall have to be provided by the candidates for facilitating refund, if any.) The registration fee of those candidates who do not join within the stipulated time after getting the allotment and those candidates who quit the seats after taking admission will be considered as penalty and will not be refunded.

Note:

1. Candidates who get allotment to the Government/Self Financing colleges should pay the entire fee to the allotted college itself.
2. Candidates allotted under the SC/ST/OEC/Fishermen Category, as well as those with benefits under G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, and G.O. (MS) 10/2014/BCDD, dated: 28.05.2014, and those from Sreechitra Home, Juvenile Home, and Nirbhaya Home are exempted from paying tuition fees at the time of admission. However, if such candidates are allotted under Management quota seats , they will have to remit the fee as shown in the allotment memo and they will not be eligible for any fee concession.

Special attention

1. The allotment of those candidates who do not take admission within the

stipulated time will be lost and such candidates will not be considered for further centralised allotment for the courses in the same stream. Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted.

2. The candidates whose results in the respective rank lists have been withheld due to various reasons can also register their online options for allotment. But the options submitted by such candidates will not be considered for allotment unless they produce the required documents to clear the defects and release their ranks before 10.09.2025, 12.00 PM.
