IMPORTANT NOTICE - MBBS (CODE 103) 2025-26 REGARDING UPLOADING OF CLASS 11TH MARKSHEET

Dear Applicants,

As mentioned in the Admission Brochure 2025-26 and University notifications pertaining to the programme MBBS (Code 103) for the Academic Session 2025-26, it is for information to all that for the seats of Delhi Category / Quota, candidates who have studied 10+2 (11th and 12th) classes in the recognized School/College in Delhi and passed the qualifying examination from any School/College located in Delhi only shall be eligible for 85% Delhi State Quota seats in MBBS Programme at North Delhi Municipal Corporation (Medical College) Hindu Rao Hospital and Dr. Babasaheb Ambedkar Medical College and Hospital.

The University vide its Notification No. 187/2025 dated 21/07/2025 advised all the NEET UG 2025 qualified candidates to upload the 11th Class Marksheet in addition to 12th Class marksheet in a single pdf while applying for admission in programme MBBS.

In this regard, it is informed that all the registered candidates (who have successfully submitted their application and have uploaded their educational testimonials, reserved category documents and NEET UG 2025 score card) will be considered for allotment of seat on merit and will not be debarred on account of non uploading of class XI marksheet. However, at the time of verification of documents (after allotment of seat), if in case, class XI marksheet is not found uploaded, a query shall be raised and the candidates need to upload the same subsequently.

This is for information to all the NEET UG 2025 qualified candidates who have registered themselves for allotment of seat through counseling conducted by the University for the session 2025-26.

Candidates are also directed to go through the "Indicative Procedure for Verification of Documents of All the Allotted & Part Academic Fee Paid Candidates (Online Counselling)_Post Verification for Academic Session 2025-2026 dated 28.05.2025 uploaded on University website vide Notification No. 57/2025, F.No.GGSIPU/DI (Academic)/Misc./2025/555 dated 28.05.2025"
